

## **SLUPU** Kesponse Time Averages: By Priority

Priority 1-3: October, 2022 through October, 2023

The following report shows response time averages for SLCPD responses to priority 1-3 calls for service during the indicated months. The overall response time is defined as the time from when the police department initially receives the call and when the first officer arrives on the scene.

The following calls were excluded from the figures:

- •Calls without a reported At Scene date/time
- •Calls with a response time of 0 seconds (i.e. on-view calls initiated by an officer)
- •Calls that are not true calls for service (e.g. Attempts to Locate, Test Cases, Info Calls, Hold Logs, Etc.)
- •Calls with obviously erroneous outlier values

In October 2023, one priority 1 call did not have accurate timestamps due to an operational issue. If that call is removed, the average is 00:09:55.


